RESOLUTION #2019-06 CHARTER COST REIMBURSEMENT AGREEMENT

This COST REIMBURSEMENT AGREEMENT, is made and entered into as of the 25th day of March, 2019, by and between Time Warner Cable Northeast LLC, a Delaware limited liability company, a subsidiary of Charter Communications, Inc., with a principal place of business located at 12405 Powers court Drive, St. Louis, Missouri 63131 Charter and Village of Clayton, a municipality organized and existing under the laws of the State of New York with a principal place of business at 425 Mary Street, Clayton, New York 13624. Company and Customer may be referred to hereunder individually, as a "Party" or, collectively, as the "Parties".

WHEREAS, in November 2016, Village adopted Local Law No. 2 of the Year 2016, which requires that all overhead utility facilities in Clayton's downtown historic district be relocated underground within forty-eight (48) months of the date of Local Law No. 2;

WHEREAS, since adoption of Local Law No. 2, Village, Charter, the New York State Department of Transportation and other affected utilities have been collaboratively working on a plan for underground utility facilities in the Village's historic district;

WHEREAS, notwithstanding the foregoing, the Parties agree that Village has not yet completed the underground conduit system and that Company will not be required to begin the Company Work, as defined below, until it receives written notice from Village that Company Work may begin; and

NOW, THEREFORE in consideration of the promises and mutual covenants set forth herein, the Parties agree as follows:
