PLEASE TAKE NOTICE that the undersigned, Treasurer of the Village of Clayton, has recently received the roll and warrant for the collection of village taxes for the 2019 fiscal year.

Payments will be accepted from June 1, 2019 through June 30, 2019 at the Municipal Building from 8:00 a.m. to 4:00 p.m. daily except Saturdays, Sundays and holidays. No partial payments can be accepted.

Payments may be made by check payable to the Village of Clayton and mailed to the Treasurer's Office, Municipal Building, PO Box 250, Clayton, New York 13624, and must be postmarked no later than June 30, 2019 to avoid penalty. Payments may also be dropped off at the collection box at the Clayton Municipal Building, 425 Mary Street, Clayton, NY or paid on-line at www.villageofclayton.com.

PLEASE TAKE FURTHER NOTICE that on all such taxes remaining unpaid after June 30, 2019, five per centum will be added for the first month and an additional one per centum for each month and fraction thereof until paid.

Effective with the July 2016 billing period, water and sewer rates for the Village of Clayton shall be as follows:

SEASONAL CUSTOMERS: In order to better serve you, please telephone the clerk's office (315-686-5552) at least 48 hours in advance of the date you wish to have your service turned "on" or "off". THANK YOU!!

Effective July 1, 2000, all water and sewer customers (including seasonal customers) in the Village of Clayton are required to pay the minimum charge three (3) times per year. NYS law requires that the water fund and the sewer fund must be self-sustaining. That is, each of the funds is required to generate enough revenues to cover the expenditures required for debt service and operation. The minimum charge for each service generates enough revenues to cover debt service. This minimum charge is assessed to ALL customers. The "per thousand" charges generate the revenues which cover operating and maintenance costs (the day-to-day operations of the treatment plants). This amount will vary according to each user's consumption, and is billed accordingly. ALL CUSTOMERS WILL BE BILLED AT LEAST THE MINIMUM CHARGE EVERY FOUR MONTHS. In the event a building is demolished, or anticipated to be demolished, the customer should contact the Clerk's office to determine when such minimum bill will be discontinued and the effective date of the final billing.
