RESOLUTION 2021-02 VILLAGE OF CLAYTON RESOLUTION STANDARDIZING COMBINATION AIR VALVES February 22, 2021

At a regular meeting of the Village Board of the Village of Clayton, Jefferson County, New York, was duly held remotely by "Go to meeting app" https://global.gotomeeting.com, in said Village on the 22^{nd} day of February 2021 at 5:30 p.m., prevailing time.

The meeting was called to order by Mayor Zimmer and upon roll being called, the following were:

The following resolution was offered by Trustee Hyde, who moved its adoption, seconded by Trustee Badour, to wit:

WHEREAS, the Village of Clayton, Jefferson County, New York is undertaking a Wastewater Collection and Treatment Improvement Project which involves replacement of several pieces of equipment in the collection system and at the Wastewater Treatment Plant; and

WHEREAS, the Village has experience maintaining certain manufacturer's brands of equipment and has developed maintenance relationships with vendors; and

WHEREAS, certain pieces of equipment included in the project for replacement are one of multiple pieces of equipment already existing within the facility; and

WHEREAS, it is necessary for the Village to standardize on certain equipment to ensure ease of maintenance and operation within the facility;

Therefore BE IT RESOLVED,

For reasons of efficiency and economy and pursuant to the authority conferred by General Municipal Law Section 130(56), it is determined by the Board of Trustees that the Village of Clayton will standardize on A.R.I. Flow Control Accessories LTD for Combination Air Valves.
